

# School Parent and Family Engagement Policy Telfair County High School 2021-2022 Revision Date - 10/05/2021

In support of strengthening student academic achievement, <u>Telfair County High School</u> receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). The policy establishes the school's expectations for parent and family engagement and describes how the school will implement a number of specific parent and family engagement activities, and it is incorporated into the school's plan submitted to the local educational agency (LEA).

<u>**Telfair County High School**</u> agrees to implement the following requirements as outlined by Section 1116:

- Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan under Section 1114(b) of the Every Student Succeeds Act (ESSA).

### JOINTLY DEVELOPED

<u>Telfair County High School</u> will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

All parents have two opportunities to provide input for the revision of the Parent and Family Engagement (PFE) Plan. In the spring of each school year, all parents receive the Title I Parent Survey. Questions on the survey focus on planning PFE activities, revising the PFE Plan, the PFE budget, building parent and staff capacity, and ways to improve the PFE program. All completed surveys are tallied, and a summary of results is created. At the end of each school year, the School PAC meets to review the survey results and to revise the Parent and Family Engagement Plan. All parents are invited to this input meeting and two methods of invitation are used. The plan is distributed and discussed during the annual Title I Parent Conference and a copy is posted on the school website prior to November 1<sup>st</sup>.

## ANNUAL TITLE I MEETING

<u>Telfair County High School</u> will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the school wide plan, and the school-parent compact.

Each school year before November 1<sup>st</sup> (2021-2022 School Year), all parents are invited to the annual Title I Parent Conference. Flyer invitations are sent home to all parents, an invitation is posted on the website, an automated phone message is sent to all parents, and the meeting details are printed in the local newspaper. Childcare is available during the meeting for parents with small children. Community resource agencies are invited to display exhibits for the parents. Parents are also given the opportunity to visit the Parent Resource Center during the meeting. The Title I program, parents' rights to know, the District Parent Involvement Plan, the School Parent Involvement Plan, the School Compact, the Parent Involvement Budget, and the School Improvement/Title I School-wide Plan are discussed with parents during the Title I Parent Conference. Spanish interpretation is available at the Title I Parent Conference so that EL parents can understand the Title I Program, the documents discussed, and their rights as parents.

### COMMUNICATIONS

<u>**Telfair County High School**</u> will take the following actions to provide parents of participating children the following:

- Timely information about the Title I programs
- Flexible number of meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation, child care or home visits, as such services relate to parent and family engagement.
- Information related to the school and parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents can understand:

- hold Parent Advisory Council(PAC) meetings and other parent activities at various times throughout the day and year.
- hold academic nights in the evenings.
- provide transportation and childcare for parents as needed and when appropriate.
- gather input about convenient meeting times from PAC members and other parents.
- send informational flyers home with students.
- send flyers home in a language that is understandable (English & Spanish).
- distribute parent surveys during PAC meeting, after parent activities, and in the spring of each year.
- distribute teacher surveys during PAC meetings. Teachers will also complete a compact revision survey during the spring of each school year.
- hold Freshman Orientation Night. High school graduation requirements, EOC tests, Honors Program, CTAE pathways, college classes and EOPA will be discussed.
- hold School Council Meetings.
- hold Open House.
- schedule parent teacher conferences when needed and as requested by parents.
- insure that the School Parent and Family Engagement Plan is made available to all parents. The plan will be posted on the website and distributed/discussed at the Title I Parent Conference. An interpreter will provide Spanish interpretation during the Title I Parent Conference when the plan is discussed.
- invite parents requesting regular meetings to formulate suggestions and participate in the decision-making process to attend the District PAC meetings, School PAC meetings, and School Council meetings. Other meetings will be arranged if necessary.
- discuss the Title I program, Parent and Family Engagement Plan, Parent and Family Engagement Budget, School Compact, and the School Improvement/Comprehensive Needs Assessment with parents during the annual Title I Parent Conference.
- collaborate with Telfair Alternative Preparation School (TAPS) to hold Parent Advisory Council meetings and PFE activities.

# SCHOOL-PARENT COMPACT

Information about Title I monies is shared by the Federal Programs Director during the annual Title I Parent Conference held prior to November 1<sup>st</sup>.

# **COORDINATION OF SERVICES**

<u>**Telfair County High School**</u> will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children by:

- hold Freshman Orientation to help upcoming 9<sup>th</sup> graders and their parents transition to high school. (Graduation requirements, the Honors Program, college classes and EOC testing will be discussed.)

- provide parent training on the use of PowerSchool as needed (Parents can check grades and attendance on PowerSchool.)
- invite community resources to display exhibits at the Title I Parent Conference.
- invite college representatives, parents, and students to a College Fair.
- provide information to parents on a parent information table in the lobby
- collaborate with Telfair Alternative Preparation School (TAPS) to hold PAC meetings and PFE activities.

## **BUILDING CAPACITY OF PARENTS**

<u>Telfair County High School</u> will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and
- Materials and training to help parents to work with their child to improve their child's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement

- send Class/curriculum home by the student.
- send information about EOC, PSAT, EOPA home by the student.
- host Freshman Orientation (Graduation requirements, Honors Program, and EOC testing will be discussed).
- hold an Open House.
- send school newsletters home to parents.
- host at least one Financial Aid Night.
- have resources available Parent Resource Center.
- hold an annual Title I Parent Conference.
- have the Georgia Family Magazine and the Parent Institute Helping Students Learn newsletter available for parents on the parent information table in the lobby.

# **BUILDING CAPACITY OF SCHOOL STAFF**

<u>Telfair County High School</u> will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

Twice each semester, teachers, administrators, and other staff will participate in professional development focused on engaging and communicating better with parents. At least one activity each semester will be an in-person or virtual PLC, and attendees will provide a sign-in sheet and feedback about the activity. The following topics will be will be the focus of the building staff capacity activities:

- the value and utility of contributions of parents
- how to reach out to, communicate with, and work with parents as equal partners

Title I funds will be used to provide transportation and child care costs as needed and when appropriate to enable parents to attend school functions. Telfair County High School has established a Parent Advisory Council (PAC) consisting of an administrator, two teachers, four parents, and the Parent Involvement Coordinator. This council meets each nine weeks to discuss and plan parent involvement activities. Parents can also volunteer to serve on the PAC and School Council committees.

TCHS encourages parents to be involved in school activities including academics and athletics. Parents participate in the Athletic Booster Club, Band Booster Club, Beta Club, Fellowship of Christian Athletes (FCA) events and other club sponsored events. Parents can also volunteer to chaperone field trips. Several organizations sponsor feeding sports teams throughout the school year.

Businesses and community members donate money and items for the school incentive program every nine weeks. Business and community leaders are also given the opportunity to serve on the School Council each year.
